Transfer of Vehicle.

person acquiring this vehicle does use it upon the public roads (other than a Trade Licence) but to dispose of it, he must send in this Book to the Registration Authority, as he acquires the vehicle, notify in writing the Registration Authority, whose address is given on page 4, that he holds the vehicle but to use it on the public roads. He must comply with instruction 10 above, on this paragraph is designed to meet the needs of other persons who do not use the vehicle but to dispose of it.)
